PITTSBURGH, PA, APRIL 20, 2017 - Matthews International Corporation (NASDAQ GSM: MATW) announced that its Board of Directors declared, at its regularly scheduled meeting today, a dividend of \$0.17 per share on the Company's common stock. The dividend is payable May 15, 2017 to stockholders of record May 1, 2017.
